Update on Alpha-Delta

This is our first traditional newsletter for the 2000-01 school year. As you are all aware, our chapter had a membership review at the end of the fall semester and has since been under the Alumni Board of Control (ABC).

The Alpha-Delta chapter has been below break-even numbers for over two years. This condition made it necessary for the alumni corporation to subsidize the operation of the chapter house. We also have one retail store that has been vacant for almost two years and we will be losing another tenant this summer. When all stores are leased, the rental income pays the house mortgage, so for the past two years the corporation also had to subsidize the mortgage payment. All of these circumstances have caused the corporation's reserve funds to become depleted.

For the proper operation of the alumni corporation, we must receive chapter house rent each semester on a consistent basis. The rent from the undergraduate chapter enables us to pay our fixed expenses and to maintain a reserve fund to cover unplanned expenditures (i.e., commercial tenant vacancies, physical plant repairs, etc.). It is critical that the undergraduate brotherhood maintains numbers above the break-even point.

At the beginning of this school year, our finances were critical and our future was questionable. We needed to react immediately or the chapter house would most likely have been lost. The first step was to determine if the current undergraduates were up to the task at hand. We felt they were, however, we saw a need for a membership review before the rebuilding process was initiated. This procedure, conducted last semester, consisted of formal interviews with each undergraduate brother. Brothers who were not completely committed to rebuilding the chapter were asked to leave. Nine brothers left as a result.

The spring term started with 15 undergraduate brothers, whose objective was to start the rebuilding process of our chapter. We began the semester with a spring retreat involving planning sessions, rush strategies and a lot of good old-fashioned house cleaning. The ABC provided a list of sanctions that the undergraduates were required to obey.

We knew after the membership review was completed, we would need considerable funds to cover operating the house for at least two semesters. The alumni board of directors sent out letters to all alumni requesting donations to cover our anticipated cash shortages during the rebuilding process. Although we received a nice first round of donations, it fell short of our needs. The chapter house account ran out of money in mid-March. Some hard

Things Are Looking Up!

As my wife and I arrived at the chapter house on the Friday evening of Blue/White Weekend, four undergraduates interrupted their conversation to greet us. They welcomed us and explained that the party room was reserved for the evening but that an informal get-together was being held upstairs. As we wandered back through the living room, we were struck by how spit-shined everything looked. We headed to the dining room to find a beer and met up with several alumni.

An undergraduate who was visiting with the alumni immediately invited me to accompany him to the kitchen to meet the current pledge class. A dozen undergraduates and pledges were in the kitchen. All stopped to say hello, with the pledges going out of their way to introduce themselves. And yes, the kitchen was clean and orderly enough to legitimately be considered a party venue.

Still eager to get that first beer, I headed back to the dining room and settled into conversation with the other alumni. Soon, another undergraduate came up to me to introduce another pledge. All through the next couple of hours, undergraduates greeted me and told me about their part in preparing for that weekend. They were genuinely excited and proud to have done such good work.

Blue/White Weekend took on special significance for the undergraduates this year. The normal pressures of hosting alumni visitors and the annual Star and Crescent Foundation awards program were certainly present. The relatively low number of undergraduate brothers made the job that much tougher. Add a little extra tension because of Saturday's housing corporation board meeting to assess the critical financial situation and to divine a way to stay open next school year, and combined with Sunday's third and the semester's final Alumni Board of Control (ABC) review, the pressure was already at finals week levels, even though final exams were several days away.

Despite that pressure, Blue/White Weekend continued smoothly. The tailgate was well attended by undergraduates and alumni. The on-field pregame protest was dispersed peacefully, Penn State won the football game and no rioting ensued. Three chapter members earned and received scholarship awards from the Star and Crescent Foundation. Dinner and the formal brothers' meeting were highlights. Light socializing after dinner followed by a knock-down, drag-out party topped off the festivities! Alumni turnout was predictably low for Blue/White Weekend, but those in attendance were truly treated like special guests throughout.

The alumni housing corporation board did meet. Excellent advance work by Ed Gorkes '79 and Doug Byler '90 contributed to

decisions had to be made fast. Essentially, we had to determine if the house would be immediately shut down or attempt to gather additional financing to keep it open.

I made an appeal to the 100 or so brothers who are active on the Kappa Sigma listserv. Many of these alumni sent in donations that enabled us to operate the house for a few weeks while we worked on the crisis at hand. Thank you to all who gave!

The ABC arranged a meeting in March with the undergraduates to determine if we would continue our efforts to keep the house open. Prior to this meeting, we discussed with the undergraduates what we would require, in addition to them following all of the ABC sanctions. Mainly, our requirements were for them to raise \$4,000 in funds to assist with the finances and to be active in securing renters in order to run the house without alumni corporation support. In addition, the house bill was increased, and the undergraduates may have to pay additional assessments if enough renters are not obtained. The undergraduates assured us that they were all still determined to get the job done.

They did a commendable job during the spring semester! They worked hard and followed the sanctions. As a group, they came together and were making good progress. Unfortunately, through no fault of their own, the money ran out.

The difficulties of the house are an accumulation of many problems that occurred over the years, and are not the direct fault of the 15 brothers who live in the house right now, but these are the people who have to make it right. It is a fairly big challenge for 15 college students to get an education, be good brothers and have fun once in a while! Envision being an undergraduate in the house during times like this. It would not be a fun place to be.

Considering all the good efforts of our undergraduates and their commitment to stick it out, we decided to stick with them, as we should. The board was successful in obtaining two loans with extended payback periods, from two alumni. These loans will keep the house and corporation operating

through the 2001-2002 school year, if certain requirements are achieved.

Part of the loan proceeds covered the chapter house expenses for the remainder of the spring semester. The remaining loan proceeds will be for the corporation reserves and will not be used for subsidizing house operations. The chapter, starting this summer, must be self-sufficient. The undergraduates must secure renters starting in the summer and throughout the school year to cover expenses until membership is above break-even. In addition, they still must follow ABC sanctions and have a very successful fall and spring rush next school year.

If any one of these areas falls short, the corporation will have no alternative but to either sell the property or rent the house to another organization.

How do I personally assess the situation? I am one of the alumni who made another loan to our chapter. I would have not written another check, unless I felt reasonably confident that the undergraduates can achieve success. Many times during my tenure as corporation president, I've felt like resigning. The

problems seemed insurmountable and the time commitment for myself and the other alumni volunteers was extensive. However, I personally could not accept the thought of losing our chapter house without a fight. Most important to my decision to remain was that the undergraduates were not quitting, so neither would I. There are still a lot of challenges ahead, but it will work if we — alumni and undergraduates — work together and support each other.

I am confident enough to keep urging (nagging!) all of you to continue financially supporting your chapter. If you have not made any donations this year, please send us a check because we really need your support. If you already donated, our heartfelt thanks go out to you, and please continue your support. The light is getting a little brighter at the end of the tunnel!

Remember that the alumni board represents the members at large. We are here to ensure that the affairs of the corporation are run properly and efficiently. We welcome all feedback, questions or ideas. Feel free to contact me at any time. We all look forward to seeing you back at the house in the near future.

Why Waste Time with Kappa Sigma?

On Blue/White Weekend, I returned to Alpha-Delta for the first time in about 15 years. I have had almost no contact with the undergraduates or alumni in all that time. And frankly, I hadn't missed it either. But somewhere in the back of my mind the whole Kappa Sigma experience was like a job unfinished. It felt like I hadn't tightened all the bolts. I had just walked away.

So I went back to answer some questions:

- What is the significance of AEKΔB at age 40?
- Is there an “adult” experience of being a Kappa Sig?
- Why should I invest my time or money in this organization?

Unlike some brothers, I have no desire to relive my youth. I love my “old age,” so nostalgia is nothing to me. I stopped drinking about 10 years ago, and I'm not looking for more time away from my wife and kids — quite the opposite.

Why should I waste my time with Kappa Sigma?

From one evening, I don't claim to have reached any sweeping conclusions, but here are a few thoughts I had.

There is a bond of sorts among those who spent several years living as brothers. You can feel it the moment the door shuts on the chapter room for the Blue/White meeting. It spans the generations. That surprised me.

We share a common desire to see the organization thrive. Even those who feel that things are really messed up want to do something to fix them.

As adults, we have something to offer these young men. Perhaps we can help them avoid some of the extremely stupid things we did in college and early in our careers. Maybe we can help them become men of character, discipline, integrity. True leaders.

Maybe the bond we already have is our opportunity to light a candle, rather than just curse the darkness. In other words, we can invest a bit of ourselves — time, talent, treasure — in the lives of several dozen young men.

Someday one of these guys may be standing over me with a scalpel ready to do a quadruple bypass. Someday I may be punching out a chad next to one of these men's names on a ballot. Someday I may be trusting one of them with a major project at work. Someday I may apply for a job at a company started by one of these young entrepreneurs. And if not me, then others will be affected by these young men.

If I have an adult experience with Kappa Sigma, it may be in coming alongside these men — together with other adult brothers — to really make a difference in their lives. Your legacy isn't just your son pledging Alpha-Delta — it can be your fingerprints on history through what you do for a few young men you'll be proud to call brothers.

Recently, I've been talking with a couple of brothers about founding a formal mentoring program and network. Maybe that's the place to start.

It has been some time since our last newsletter, and much has occurred since then. As many of you know, we are at a pivotal point that will decide the future of the Alpha-Delta chapter of the Kappa Sigma fraternity.

We undergraduates have made a pledge to the alumni in return for financial assistance and guidance. We have set up committees for summer and fall rush and have drafted the backbone plan for each, organized a fundraiser lottery, and are still exploring more activities. We have made an

effort to keep our chapter house in the cleanest of conditions and are actively marketing our house for summer and fall renters. With the addition of these renters, the housing corporation can be profitable once again throughout the summer, fall, and into the future. It is our hope that the rush plans we have developed will negate the need for renters in the future and for our house to have the proper numbers to fill the financial gap.

Earlier this semester, five new men were initiated into our order: Rob Lesko '04, Adam Kulp '04, Phil Wantuck '04, Rob Drelich '04 and Mark Coldren '02. They have already stepped up for us by taking active rolls in IFC and positions in the house, as well as bringing new freshman blood and life back into this chapter.

For this semester, we had four new pledges. While short of our intended goal, it met the average number that the fraternity system pledged for the semester, and was accomplished with far less manpower. With a solid rush plan focusing on the incoming freshmen arriving during the summer as well as the fall, we fully anticipate quadrupling this number by next autumn.

The Dance Marathon went very well this year, raising \$3.6 million for children with cancer. We are all very proud of our involvement with such a worthy event. We're hoping to increase our commitment next year by obtaining corporate sponsorship to raise more money, and with higher numbers and a greater individual effort. We are also setting up a program with the Red Cross for either a blood drive or canning trip, with details still being ironed out by the executive and philanthropy committees.

The house has made significant scholastic improvement. Following the expulsion of several members, our GPA for the house has climbed to approximately 3.09, which is in the upper 20 percent! We'll have to wait until next year for these changes to be officially recognized, per IFC policy.

Great steps have also been taken to increase our presence in IFC. We currently have seven brothers involved, with more interested in becoming involved. I can't stress enough that your continuing support is needed and appreciated for our chapter's existence. I encourage everyone to visit the house as time permits and see firsthand the progress we have made.
